Dear Hawkeye Country Angus Sale Contributors,
Subject: Sale Entries and Deadlines

Plans are well underway for the 31st Annual Hawkeye Country Angus Sale to be held at the Bloomfield Livestock Market, Bloomfield, IA on Sunday, June 5, 2022. This year's sale will be managed by the Missouri Angus Association, Kody Graves, Sale Manager, 940-531-1851. Conover Auction Service will still be involved with the sale as auctioneer and accounting.

We encourage your participation in this important Angus event and would appreciate your timely response to the following entry guidelines. **Please read carefully.**

Entry fees are \$70.00 per head (this includes cows with new babies at side) and \$100 for split pairs. **Entry deadline is April 18, 2022. Please note: entry forms and checks are to be mailed to the Sales Manager, Kody Graves. However, the entry checks must be made payable to Conover Auction Service.** Entry fees will be treated as advance sale expense and are non refundable.

In order to print a timely catalog, we will need the following information provided to the Sale Manager: Copies of pedigrees, AHIR data (weights, ratios, dam's production, etc.), general footnote information - including any pertinent pedigree information and breeding information- (including A.I. date and/or pasture breeding dates, service sires, pregnancy check and safe to dates.) Good quality pictures may also be included or emailed but are subject to sale manager's approval.

We would appreciate your cooperation by providing us with your **American Angus Association member number and password.** Your password (which will remain confidential) allows the sale management staff to get the information needed for catalog preparation without making numerous phone calls.

Consignors will be asked to sign a sale agreement form (enclosed) which explains that sale commission will be charged on any floor prices or reserved bids at the final price the lot goes out the ring at, either sold or unsold and pay the appropriate sale expense.

It is required that bulls over the age of 24 months or any non-virgin bull, requires a single negative "Trich" test after May 15, 2022. A statement denoting status of virgin bulls must be noted on the Certificate of Veterinary Inspection. Bulls will also need to be semen tested and a scrotal measurement taken. Such exam must be noted on the official Certificate of Veterinary Inspection or may be presented on a Certificate of Fertility Evaluation.

Please mail your completed entry forms and entry fees to me at the above address as soon as possible. If you have any questions, please feel free to contact me. Thank you in advance for your participation.

It is understood that Conover Auction Service Inc. will be doing the sale accounting for this sale and will be collecting the sale proceeds. We understand that sale proceeds will be disbursed within a 60 day period. We are also aware that any claims against them must be filed, in writing, with the Packers and Stockyards Programs within 60 days from the date of the transaction to which the claim is based. Compliance with these Packers & Stockyards Act and Regulations will be beneficial to everyone, as we bring buyer and seller together.

I also understand that all consignments will be charged a uniform sales commission to cover shared expenses from all consignors for advertising, catalogs, sale facilities, etc. I do agree that commission will be charged on any floor prices or reserve bids at the final price the lot goes out the sale ring at, either sold or unsold, and agree to pay sales expense on that final price.

It is also understood that when selling embryos, the consignor guarantees at least 50% conception if implanted by a certified technician.
