Subject: Sale Entries and Deadlines

Plans are well underway for the 23rd Annual Midwest Connection Angus Sale to be held on Sunday, ***December 6th, 2020*** at the Bloomfield Livestock Market, Bloomfield, IA.

The Midwest Connection Sale has a much storied past playing host to some historic herd dispersions and memorable individual Angus transactions. In an effort to revive the significance and importance of the Midwest Connection tradition we have selected a glamorous location and have asked progressive Angus breeders like yourself to participate. The Midwest Connection Sale has, in the past, featured bulls, bred cows, donor cows, bred heifers, open heifers, steers, pregnancies, embryos and semen. That will continue to be our endeavor. **NOTE:** Any **NON-VIRGIN** bull selling in this sale will need to be Trich tested. Please consult your veterinarian to have this test done before sale time and stated on the health paper.

We welcome your participation in this important event and your Angus friends that we may have overlooked. We would further appreciate your timely response to the following entry guidelines.

1. **Entry deadline is October 28, 2020.**
2. In order to print a timely catalog, we will need the following information provided to our office: Copies of pedigrees, AHIR data (weights, ratios, dam's production, etc.), EPDs, general footnote information - including any pertinent pedigree information and breeding information- (including A.I. date and/or pasture breeding dates, service sires, pregnancy check and safe to dates.) Good quality pictures may also be included or emailed but are subject to sale manager's approval.
3. We would appreciate your cooperation by providing us with your American Angus Association member number and password, if you have not already done so. Your password (which will remain confidential) allows the sale management staff to get the information needed for catalog preparation without making numerous phone calls.
4. Consignors will be asked to sign a sale agreement form which explains that sale commission will be charged on any floor prices or reserved bids at the final price the lot goes out the ring at, either sold or unsold and pay the appropriate sale expense.

We understand that sale proceeds will be disbursed within a 60 day period. We are also aware that any claims against them must be filed, in writing, with the Packers and Stockyards Programs within 60 days from the date of the transaction to which the claim is based. Compliance with these Packers & Stockyards Act and Regulations will be beneficial to everyone, as we bring buyer and seller together.

I also understand that all consignments will be charged a uniform sales commission to cover shared expenses from all consignors for advertising, catalogs, sale facilities, etc. I do agree that commission will be charged on any floor prices or reserve bids at the final price the lot goes out the sale ring, either sold or unsold, and agree to pay sales expense on that final price.

It is also understood that when selling embryos, the consignor guarantees at least 50% conception if implanted by a certified technician.
